Dear People of God,

Looking Back at 2019:

We are so very grateful for the generosity of the St. Andrews Family. Because of you, we were able to support Presbytery Appeals like the Birthday Offering, Blanket Sunday, Thank Offering and the Missions of Presbyterian Women of the Carlisle Presbytery. Through Celebration Giving and the Bakeless Bake Sale, we supported local, state, national and International Missions such as Agape, the Ronald McDonald House, Lebanon County Christian Ministries, Lebanon Rescue Mission, DVI of Lebanon County, Ting Ministries, Lend-a-Hand, Sunset Gap TN Community Center, American Foundation for Children with AIDS, and Glad Tidings India. In addition, because of you, we filled 50 stockings with toiletries and other items for Church Women United, who distributed them to women in Lebanon County nursing homes, and our used clothing appeal yielded dozens of bags of clothing which were delivered to area agencies.

We completed our 3rd year of Active Community Outreach by serving meals to the children of True Life Youth Ministries (formerly Youth for Christ) on the first Thursday of each month. This outreach has proven to be a truly heartwarming experience. Roz Presby led an interesting and thought-provoking Spring Bible study, and the Tuesday Sewing Group continued to sew for charity each week. The proceeds from the Christmas Craft tables fund the sewing group's projects.

Looking back at 2019:

2019 started with the promise/hope that all the problems were solved - the steeple was fixed, the sinkhole was filled, and the parking lot ready for the final macadam application, the HVAC system was purring – we were ready to coast through 2019.

Many things did go smoothly — lawn care and spring planting (thanks to Glenn Royer) went well; major yard clutter and pruning was completed; the Kitchen Exploratory Committee was active and new kitchen faucets were installed (and more updates will follow); a new trash hauler was contracted to start January 2020 (saving over \$300/ yr.); insurance premiums were lowered; continued upgrade to LED lighting is almost completed; the church office has equipment upgrades — new copier and folding machine — we are working with Visioning Committee on their plans for upgrades of the Prayer Labyrinth and development of an area to attract the public and carpet cleaning was completed.

BUT it didn't take long for problems to arise. A new sinkhole "appeared." It was filled. But the final macadam application was postponed. It was finally completed in mid-June and the parking lot re-lined. We keep our fingers crossed that this is the final challenge.

For a long time the Trustees had been discussing painting projects and Mission Week provided a good starting point. The plan was to do the wall prep in the hallway between the area under the Narthex and the Christian Ed classroom hallway plus the classroom at that corner (the home of Band Together). Don Beatty started to prep away but found water damage in both areas thereby postponing the painting project and starting the search for the source of the water. It was noted by a few "old" members and the contractor that the North wall was always a problem. Initially it was discovered there was clogging of the drain pipes from the downspouts to the storm sewer at the intersection of 12th and Poplar and the possibility of replacing this system was estimated at \$40,000. But further investigation revealed that with heavy rain there was overflow of the gutters which was blown by the north wind into the wall. The overflow problem underwent a temporary fix and since then the interior walls have remained dry. It is the hope that less expensive corrections to the gutters and downspouts will correct the problem for a much lower cost. Then there was the elevator. We were blindsided by an inspection that resulted in us being in violation — no functioning alarm bell/no phone. This resulted in some special instructions for those using the elevator. A dedicated phone line ws installed and after many attempts we finally had the elevator repairs done to give us an alarm and allows full use. A phone (which we never had but will provide max safety) will be installed.

There was one goal that was not met. We had planned to organize documents so that there would be a record for what previous decisions/investigations/work had been completed so we could avoid the waste of time/effort when facing issues only to find that they were not "new" problems but had been dealt with in the past. To quote T.S. Eliot: "We shall not cease from exploration, and the end of all our exploring will be to arrive where we started and know the place for the first time."

Plans for 2020:

Continue to respond to ideas coming from the Kitchen Committee; final resolution of the water drainage problem and with that resolved complete the painting of hallway and Christian Ed room; install a phone in the elevator; see the trees removed that were to have been removed in 2019; CPR class for staff and interested church members; and change the entry codes for the back door, to go into effect 2/1/20.

We stand by for what unexpected challenges 2020 will provide.

Throughout the year we have continued our commitment to spiritual outreach both within our congregation and in the larger community. Leading the way have been our Sunday school teachers and aides, who have willingly assumed their weekly obligation to lead our children, youth and adult members in their classes: Rick Borger, Tim Chevalier, Mel Cochran, Connie Dowhower, Karen Fedder, Ken Gries, Lisa Hamme, Barry Kohr, Mary Lynne Mulligan, Tim Peelen, Penny Samuelson. Maggie Beattie, Rob Cochran, Lorraine Lowrie and Jere Shiner once again led the Confirmation Class. St. Andrews is truly blessed in having the leadership and commitment of these individuals who are absolutely essential to the educational ministry of this congregation.

Our focus on community engagement continued in 2019 as the Christian Education Ministry supported the ongoing projects of the Little Free Library and the Free Pantry, originally developed by Shelby Lister, and the interactive Lenten prayer wall. We reached out to 13 college students with notes and care packages, hosted young people from our Lebanon community in the Krislund Traveling Camp, encouraged the community to be part of the Creation Festival, and held an October Trunk or Treat outreach celebration for all in our parking lot.

A major priority for 2020 is to find an alternative to the Krislund Camp program in which we have participated for the past several years. Under new leadership, Krislund has changed its policies and practices which will significantly limit our ability to participate in its programs. A Task Force consisting of Betsy Sensenig, Kayla Lowrie, Tim Peelen and Perry Latshaw will study possible alternatives to Krislund and will plan for a summer program to be held here at Saint Andrews to replace it. To be successful, such a program will need the support and participation of the members of the congregation. Come and join in the excitement and joy of creating a new program for God's children!

The kids have also taken to the lessons from What's in the Bible with Phil Vischer. It is a great moment to sit with them and hear them recall the lessons and see how Tim, Marylynne, and Melynda are reinforcing these lessons in the group.

Looking ahead at 2020:

This school year 2019/20 one of my objectives has been for a youth mission trip. I am looking forward to this opportunity to work in the mission field with the students. Mission work and service to the community provides unique opportunity for everyone to connect and grow in the love of God. I look forward to this opportunity with the youth and the connections that it will build.

MISSION

SPECIAL OFFERINGS The four PCUSA Special Offerings were collected including: One Great Hour of Sharing, Pentecost, Peace and Global Witness, and Christmas Joy.

LEBANON COUNTY CHRISTIAN MINISTRIES St. Andrews supports this ministry in many ways. Robin Gries and Betty Ann Seiser are St. Andrews Delegates to LCCM. The "Monthly Spotlight" saw over 575# of donations of much needed food and personal care items. Instead of food for 3 months we collected new socks, underwear, and T-shirts and delivered them. During the 2 months we host Emergency Shelter Program, "Fresh Start" we collected juice and snacks for the shelter guests. Those two-week periods, twice a year are hosted by wonderful St. Andrews volunteers. On the second Saturday of every month in Snyder Hall, groups committees and boards of the church hosted, prepared, and served the Free Noon Meal. In November, we supported the annual fundraiser by providing a themed basket for the Silent Auction.

ALTERNATIVE GIFT FAIR This year marked the 15th annual fair raising money for charitable organizations, while giving an opportunity to provide alternative gifts for family and friends. Over \$4,000 was raised through donations to Lebanon Community Library, Lend A Hand, PCUSA Medical Benevolence, Habitat for Humanity, Heifer International, Compassion International, LifeWater International, and Fair Trade items.

CHRISTMAS ANGEL TREE Church members generously provided Christmas gifts for children who are under the care of Lebanon County Children and Youth Services. A mitten, glove, scarf, and hat collection was also taken for distribution through LCCM and Agape Shelter.

COLLECTION CORNER The corner across from the church office continues to be put to good use. The rebates for the ink cartridges go into the EPYC fund. Aluminum pull tabs are collected for the Ronald McDonald House in Hershey. Food and personal care items are collected for LCCM as well as for our Little Free Pantry. Box Tops for Education are collected for Jack and Jill, and aluminum cans are collected for Habitat for Humanity.

MISSION WEEK Plans began in February for the August 4-10 week dedicated to giving back to the community. It started with a congregation-wide kick-off of mission projects at church on Sunday, directly after the service. During the week volunteers painted a building at the Northeast Playground; provided a meal at the VA hospice, assembled school kits at Mission Central; hosted DDS clients for a bingo night; cleaned up portions of the local Rails to Trails; and prepared and served the Free Noon Meal. Ages of participants spanned multiple generations, working side by side to share the Light of God in the world. Jesus's disciples are never too young or too old to "do something" in service to Him and the world that needs Him.

Looking back at 2019:

The Visioning Committee (then chaired by Scott Shreve) lead a Leadership Retreat involving the Session as well as other church elders. Many ideas came out of that retreat, but one that kept recurring was that we should find ways to grow our church and be a welcoming presence in our community. We also discussed ways to improve our physical space to make it more community friendly and inviting. At times, the tone of the conversation was difficult, but this is to be expected when tough issues are being discussed.

In March of 2019, the committee hosted an enjoyable afternoon game of Bingo in Snyder Hall. Attending were members from Developmental and Disability Services. Members of the Committee provided snacks, prizes, and encouragement to the players. The Committee did the same thing again in August of 2019 during Mission Week. It was a wonderful gathering and we plan to do it again in Spring 2020.

The Committee served the free noon meal in November 2019. It was an especially busy day, as we fed a hot meal to over 70 people. We even ran out of food! We will do so again as needed.

Looking ahead to 2020:

The Visioning Committee is following up on ideas from the retreat as well as in *The Agile Church*. This book discusses how people do not "do church" the way they used to. Our committee wondered: is there a way to let our community *know* they are welcome to share our space? Can we utilize the beautiful green space we already have to its full advantage while also inviting our community to share it with us? Could doing so attract young families onto our property, and then, into church?

We are proposing a project to expand the boundaries of our church by creating an outside space for prayer and play. After reviewing our current Safe Sanctuary Policy, it was determined that we needed to add a statement to the policy dealing with Social Media. Working with our insurance carrier, a statement to address this need was written, and the updated Safe Sanctuary Policy was prepared, sent to the Session, and then approved.

Our top two accomplishments in 2019, were the ongoing updating of our policy book where needed, and approving a social media consultant to upgrade St. Andrews Presbyterian Church's Facebook page.

Looking ahead at 2020:

Representing the Session in dealing with matters of staffing needs, website issues and policy updates will continue to challenge members of the A&P Committee as we look forward to 2020.

The Committee decided that their #1 focus will be to continue to support and nurture the church staff.

SAFE SANCTUARIES POLICY ST ANDREWS PRESBYTERIAN CHURCH LEBANON, PA.

The Session, in an effort to continue the goal of St. Andrew's Presbyterian Church to foster a friendly, stimulating and thoughtful place for children to know God and experience the love of Jesus Christ by our example and God's blessing, adopts the Safe Sanctuaries Policy and pauses to reflect upon what Jesus was saying about how we are to treat one another, especially children.

"An argument arose among them as to which one of them was the greatest. But Jesus, aware of their inner thoughts, took a little child and put it by his side, and said to them, "Whoever welcomes this child in my name welcomes me, and whoever welcomes me welcomes the one who sent me; for the least among all of you is the greatest." - Luke 9:46-48

The goal of the Session and therefore the goal of St. Andrews Church in adopting this policy is to provide a safe environment for the children who visit St. Andrews and worship at St. Andrews while at the same time strive to encourage staff and volunteers to continue to work with our children.

The Session, in adopting this policy, recognizes that a child, despite the good intentions of the institution within which the child dwells and is learning, can and has been by history the victim of those who would violate the individual's person and thus violate our church family.

GUIDING PRINCIPLES OF ST. ANDREW'S POLICY

To provide a safe environment for all children and youth attending St. Andrews church school, attending other activities at the church and attending activities sponsored by the church but away from the church property.

To continue to place in service teachers and volunteers who are spiritually and emotionally mature and respect the child as an individual.

To create standards which will not impede the efforts of St. Andrews to provide Christian ministry, volunteerism and at the same time, maximize safety of our children and to uphold the current legal requirements.

INTENT OF THE POLICY

The goal of St. Andrews in formulating for our children a safe sanctuaries policy, is to do all we reasonably can do to protect any child or youth from being physically, mentally or sexually abused while participating in St. Andrews sponsored events.

A BASIC PROCEDURE TO PROVIDING SAFE MINISTRY FOR OUR CHILDREN AND YOUTH

A. TWO ADULT RULE

Any activity sponsored by St. Andrews church, whether it is a program, event, or a ministry involving children, shall require two unrelated adults being present.

B. FIRST AID AND TRAINING (CPR)

St. Andrews will put into place and/or make available to all staff who work with children first aid and CPR training.

C. ANNUAL ORIENTATION (STAFF/VOLUNTEERS)

Staff, who work with children and youth, and volunteers, who regularly work with children and youth, shall receive an orientation for the purpose of being acquainted with:

1. St. Andrews policies for providing safe sanctuaries for children;

2. Appropriate steps to report an incident where a child has been abused and details of state laws regarding child abuse.

D. FIVE YEAR RULE

All paid staff of the church shall be a minimum of five years older than the children or youth they are supervising. This rule shall also apply to volunteers who assist in youth ministry or aid in youth activities except where the volunteer is assisting an adult who complies with this rule. This rule acknowledges that St. Andrews uses volunteers from its senior high students during Church school for the lower grades.

E. OPEN DOOR POLICY

Staff and volunteers shall at all times maintain the doors to their classrooms or counseling sessions with youth open and if doors are closed, then the room in which the activity is taking place should have glass panels through which someone outside the room can view the entire area.

F. SOCIAL MEDIA AND ELECTRONIC COMMUNICATIONS

Social media and digital communication are a reality in our culture. There are ministry opportunities within the use of social media and digital communication, but there is a need for safety guidelines and practices for all staff and volunteers of the church to ensure the safety of children and youth. Below are guidelines to enable appropriate communication with students through current and future forms of social media (Facebook, Twitter, Instagram, Messenger, Etc.) and digital communication (Phone calls, Texting, Messaging and video chat services, Email, Etc.).

- All forms of electronic and digital communication shall be transparent. No form of electronic or digital communication shall be considered confidential. Upon request any form of communication will be made available for review by parents, guardians, staff, and appropriate parties as determined.
 - Due to this requirement for transparency, no form of self-deleting/ destructing messaging should ever be used in communication with children, youth, or families.
- Following/friending a child or youth will be initiated only by the child/youth. (If a child/youth follows or sends a friend request, the parent/guardian will be informed).
- While communication has adapted and moved to digital forms, it is best to pursue emotionally charged or sensitive conversations in a direct face to face interaction for clarity of communication of emotion and intent. (See section A., D., E., I., and J. for expected practices).
- All electronic and digital communications are subject to the Safe Sanctuary policy as well as all mandated reporting requirements. (See section A., D., E., I., and J. for expected practices).
- Caution is to be used in the time that communication happens with students. While it is understood that there are emergencies, communication should fall within a home phone guideline of 9am-9pm.
- All adults, especially staff and volunteers will take care to ensure their communication with all children and youth is appropriate. All adults will intentionally refrain from inappropriate electronic communication including but not limited to:

Harsh, coercive, threatening, intimidation, shaming, derogatory, demeaning or humiliating comments Sexually oriented conversations and images. Any self-deleting/destructing form of communication

G. ADVANCE NOTICE TO PARENTS

During an event for ministry with children and youth, advance notice to parents and full information regarding the events, the adult and/or young adult participants shall be given. All curriculum and materials for children and youth will be available for review, upon request.

H. PARENT AND FAMILY EDUCATION

(and a session for children)

St. Andrews shall provide on occasion an information session during which members of the congregation, families and children can be educated on the facts about child abuse and the components of the church's plan. Suggested speakers and activities could include law enforcement officers, members of the local Children and Youth Agency, medical personnel, attorneys, video vignettes, the church policy and a time for worship and prayer.

I. RESPONDING TO ALLEGATIONS OF ABUSE

All staff and volunteers shall be acquainted with the reporting requirements of PA State Law and shall be familiar with this policy.

The Designated Spokesperson is the Elder from session, who is chair of the Administration and Personnel Committee. If an alternate spokesperson is needed, the Clerk of Session shall act as the designated spokesperson. All questions or contacts with respect to child abuse shall be directed to her or him.

The designated spokesperson should be prepared to state the church policy for prevention of child abuse, the concern of the church for the safety of the victim and all children, and the procedures the church has followed to reduce the risk of abuse to children.

The designated spokesperson shall, upon report or notification of abuse, contact the insurance company for the church, the attorney and prepare a brief statement, that will as far as it is possible respect the confidentiality of all in involved. The Brief Statement will be a part of the Safe Sanctuaries report at the Annual Meeting of the congregation. The spokesperson and all staff will cooperate fully with any investigation by law enforcement authorities.

Notification to Parents. When an incident of child abuse from outside of the immediate family is suspected or reported, the designated spokesperson for St. Andrews shall with all due diligence notify the parents of the child.

Sympathetic Concern of the Victim. St. Andrews is committed to the faithful response to the victim which shall include taking any allegation very seriously and respecting the victim's privacy as well as providing sympathetic concern for the victim and his or her family.

Removal of the Accused from Position Without Hostility. Faithful response to the accused abuser shall include acknowledgement by the accused that the abusive behavior must stop, repent and turn in a new direction. The accused faithful response will include the removal from his or her position as a worker or volunteer with child and youth until the allegations are fully investigated and resolved. The session shall have the authority to provide for permanent removal upon a showing of abuse.

Criminal History and Information Check. St. Andrews currently has in effect a requirement that all staff and all volunteers, who regularly supervise and/or are responsible for children or youth, submit forms for:

- 1. Pennsylvania Child Abuse History Clearance
- 2. Pennsylvania State Police Criminal Record Check
- 3. Federal Bureau of Investigation Criminal Background Check (volunteers may provide a signed affidavit if they have resided in PA for 10 years or more)
- 4. Complete the required training.
- 5. Have all of above updated every 36 months

J. HOW TO REPORT:

All staff and volunteers shall immediately make a report of any suspected abuse directly to the PA Department of Child Welfare.

A report must be submitted in one of the following two ways: >Orally to the PA Department of Child Welfare Information Solution @ 1-800-932-0313 which must then be followed up within 48 hours with a written report

OR

>Mandated Reporters Must Submit a Written Report Online, submit a report online within 48 hours to <u>www.compass.state.pa.us/cwis</u> where St. Andrews Presbyterian Church is registered as an organization

After a report has been submitted, one must immediately report any suspected abuse to the designated spokesperson of St. Andrews Presbyterian Church, providing the spokesperson with a copy of the written report submitted to the state.

*****IT IS NOT YOUR JOB TO DECIDE WHAT IS ABUSE, ONLY TO REPORT ANY SUSPECTED ABUSE.** Penalty for failure to report child abuse can range from a misdemeanor of second degree to a felony of the second degree.

K. CONGREGATION.

The Session shall acquaint the members of the congregation with the policy in summary form; and, provide copies to anyone upon request.
